- National clinical guideline for stroke for the UK and Ireland SIGN The national clinical guideline for stroke provides authoritative, evidencebased practice guidance to improve the quality of care delivered to every adult who has had a stroke in the United Kingdom and Ireland, regardless of age, gender, type of stroke, location, or any other feature.
- Lung cancer State of the nation report (NLCA) HQIP This report summarises the performance of lung cancer services on a set of performance indicators and patient outcomes.
- Non-accidental injuries in infants attending the emergency department

This investigation explores the issues that influence the diagnosis of nonaccidental injuries in infants (children under 1 year of age) who visit an ED. Specifically, it explores the information and support available to ED clinicians to help them to make such a diagnosis.

Two lipid management pathways – one for acute cardiovascular disease in secondary care and one for primary care clinicians – have been developed to provide clear and simple guidance for clinicians on how optimal lipid management may be achieved and provide an additional resource to support patient management.

<u>Tackling obesity: Improving policy making on food and health</u> Institute for Government

This report is the first in a series from the Institute for Government on chronic policy issues that successive UK governments have failed to tackle – areas where problems are deeply ingrained and have severe long-term impacts, but solutions have remained out of reach.

 One-stage hip revisions are as good as 2-stage surgery to replace infected artificial hips NIHR

Most people recover well after a hip replacement, but some will develop an infection. This can mean the artificial joint needs to be replaced in one- or 2-stage surgery. Research found that one-stage hip revisions were as effective as 2-stage procedures at relieving pain and improving hip stiffness and function. One-stage procedures were also better value for money.
