Quality and Safety

This major new report sets out how the health and social care system can work better this winter – by avoiding unnecessary hospital admissions and improving patient flow.

This report explores how the services which deliver medicines to patients in their home could improve care for patients and reduce pressure on the NHS but that this significant potential is not being met.
